- All meals and lodging are covered by RMFU.
- If you have a previous application on file, you must reapply to be eligible for 2024
- You must be present at camp on the following dates:
 June 28-July 1, 2024: Senior Camp, YMCA of the Rockies, Estes Park, CO
 July 19-22, 2024: Junior Camp, YMCA of the Rockies, Estes Park, CO
